ISF-5 WORKSHEET INSTRUCTIONS TRANSIT CARGO

- 1. **DATE**: Enter today's date
- * 2. VESSEL NAME & VOYAGE #: Enter the name of the vessel with correct voyage number
- * 3. DATE OF LADING: Enter the date the container was loaded on the U.S.-bound vessel.
 - 4. **FOREIGN PORT OF LADING:** Enter the foreign city name for the foreign port of departure
 - 5. **ARRIVAL PORT IN U.S.**: Enter the U.S. city name for the port of arrival
- * 6. **AMS BL #**: Enter the bill of lading number (with SCAC code) of the "lowest" bill of lading. That is, the house bill of lading or regular (i.e. simple, straight) bill of lading. You **must** include the SCAC code of the party who transmitted the BL to AMS.
 - 7. **REFERENCE/PO#**: Enter World Exchange's reference number for the shipment
 - 8. TIME OF LADING: Enter the time the container was loaded on the U.S.-bound vessel
- 9. **ETD**: Enter the estimated date of departure at the foreign port of lading
 - 10. TIME OF DEPARTURE: Enter time the U.S. bound vessel departed the foreign port.
- * 11. ETA: Enter the estimated date of arrival at the U.S. port of arrival

The Following Information Must Be Provided No Later Than 24 Hours Prior to Foreign Lading:

- * 13. **BOOKING PARTY**: Enter the name and address of the party who initiated the reservation of the cargo space for the shipment
- * 14. **SHIP TO PARTY**: Enter the name and address of the first deliver-to party scheduled to physically receive the goods after goods have been released from Customs custody
- * 15. **COMMODITY HTS#(S)**: Enter the classification number, provided at least to the six-digit level, of the commodity, as listed in the Harmonized Tariff Schedule of the United States (HTSUS)
- * 16. **COUNTRY OF ORIGIN**: Enter the country of manufacture, production, or growth of the commodity or commodities
- * 17. FOREIGN PORT OF UNLADING: Enter the port code for the foreign port of unlading at the intended final destination. For shipments being exported to Canada or Mexico by rail or truck, you may use hite first foreign port of entry (or nearest city) after export from the United States. If you do not know the port code, enter the city and country
- * 18. PLACE OF DELIVERY: Enter the city code for the foreign place of delivery where the carrier's responsibility for the transport of the goods terminates. If you do not know the city code, please list the city and country.
